VENDOR GUIDELINES

DATE/TIME: Saturday, September 13, 2025 from 9:00 AM to 4:00 PM LOCATION: John Clark Park, 1009 Commerce Street, Esto, FL 32425

BOOTH SPACES: Each booth space measures 12' x 12'. If you are using a trailer, please ensure that the dimensions of the trailer include the trailer tongue. Vendors requiring more than a 12' x 12' space must purchase additional spaces. All items must fit within the space you purchase. Vendors must provide their own tent, tables, chairs, etc. Booths are assigned on a first-come, first-served basis.

ELECTRICITY: Electricity is not available.

SETUP: Setup may begin at 6:00 AM on Saturday, September 14th. Booth Setup must be complete by 9:00 AM. Vehicles will not be allowed to stay in the park. All vehicles must be removed from the festival grounds by 8:00 AM.

BREAKDOWN: Booth breakdown may begin at 4:00 PM, when the festival ends. No vehicles may enter the festival grounds before 4:00 PM.

PHOTOGRAPHS: Please email 3 high-quality photos of the items being sold in your booth to info@twotoedtomfest.com. Photos will be used to promote the festival on social media.

REFUNDS OR CANCELLATIONS: There are no refunds. This is an outdoor event and will take place rain or shine.

BUSINESS LICENSE: The Town of Esto does not require a business license for this one-day event.

SALES TAX: Vendors are responsible for collection and payment of sales tax. Holmes County's sales tax rate is 7%.

BOOTH RESTRICTIONS: Vendors with duplicate products will be limited. Only food vendors can sell food and beverage items. The sale of alcoholic beverages is not allowed in any booths. The following items are prohibited: explosive devices, guns, garage sale/flea market items, sexually explicit or drugrelated paraphernalia. Sharing and subleasing booths is not permitted.

FOOD VENDORS: Duplicate menu and vendors will be limited. Please submit a full menu with your application. The sale of alcoholic beverages is prohibited.

LIABILITY WAIVER: By submitting an application and payment, vendors agree to hold harmless The Town of Esto, the Two-Toed Tom Festival, its employees, volunteers, sponsors, etc., from any lawsuits or claims based on property/possession loss or damage. Vendors agree to comply with the rules set forth by the Two-Toed Tom Festival.
